The DEC is updating chronic wasting disease regulation and is offering an opportunity for public comment. Four changes are proposed:

- 1) Decommission the current CWD containment area.
- 2) Rescind provisions related to sale of feed.
- 3) Require that taxidermist logs be kept on hand for two years.
- 4) Add moose as a regulated species if CWD is discovered in the animal.
